<p>NPC/25/60 Reports</p>	<p>Suffolk County Council:</p> <p>Local government review - A letter from government was sent to 63 councils to ask their opinion that if elections were to be postponed in May would that release additional capacity to complete the LGR in a more timely fashion. Some of the councils in the response addressed the issue of postponing elections. SCC chose not to do that. Cllr. Mulcahy felt that elections should go ahead in May - not what conservatives thought she therefore resigned from the party on Friday to express concerns about not having elections. Has since joined the Reform party. The timeline of LGR decisions should be known in February. Cllr. Mulcahy stated it is undemocratic not to have an election in May.</p> <p>Business cases are currently being reviewed by the government - by March a decision should be made on what offer to move forward with.</p>
